#### **Microsoft Agreement**

The current Microsoft agreement expires shortly and needs to be renewed ready for renewals due on 30 November 2014 (some Universities will renew in February 2015).

The first planning meeting will be held in March and we are seeking further information and support to kick-off the process. We will be working closely with the Strategic Procurement Advisory Committee and the University Software Licensing Collaboration (USLC) community of practice to gather feedback on the current agreement and to form a small team to assist with negotiation.

#### **Australian Privacy Principles**

The Office of the Australian Information Commissioner (OAIC) has released the finalised Australian Privacy Principles (APP) guidelines following public consultation. The APP guidelines are an essential tool for all entities that are covered by the Privacy Act and will be subject to the new APP's from 12 March 2014

The APP guidelines outline the mandatory requirements of the APP's and how the OAIC will interpret the APP's and matters they will take into account when exercising functions and powers under the Privacy Act. The APP guidelines give many examples of how the AAP's may apply in particular circumstances and contain suggestions for good privacy practice. The guidelines are available on the OAIC website.

IT News/Haymarket Media sought some legal opinion on the upcoming law changes and have published the <u>following document</u> to assist Australian businesses.

Hot of the press: The Australian Information Commissioner and Privacy Commissioner have issues a statement of the Australian Information Commissioner's (OAIC) enforcement approach to new privacy laws from 12 March 2014. Read the statement.
