2014 EDUCAUSE Study Tour



CAUDIT has commenced planning for the 2014 CAUDIT 'EDUCAUSE Study Tour. The Study Tour will commence immediately after the closing of the EDUCAUSE 2014 conference. i.e. participants will be able to go straight from the conference to the Study Tour. [The conference](#) commences on Monday 29 September with pre-conference seminars, then the 'conference proper' running from 8:00am Tuesday 30 September to 11:15am Thursday 2 October.

At this early stage, the Study Tour is likely to commence either 'with' or following lunch on the Thursday 2 October, starting off in Orlando Florida and working its way back across the USA ending up in Los Angeles for departure on the following Wednesday 7 or Thursday 8 October. One option may be that participants can elect to 'drop off' i.e. exit the tour as it progresses across the country. The major proportion of time will be spent on university site visits rather than vendor visits. It's early days, however, block out the dates in your diary now.

CAUDIT Working Parties

Inaugural meetings of the four CAUDIT Working Parties: Digital Literacy, Partnership & Engagement, Research Support and Wireless were held before Easter to endorse their respective Terms of Reference, commence a work plan and schedule future meeting times. Working Party Members attending the 2014 Autumn Members Meeting met face-to-face at the Networking /Special Interest Group session. Future meetings of the four Working Parties are being scheduled in the last two weeks of May 2014 with subsequent meetings planned every six weeks until the end of September 2014.

Benchmarking Advisory Committee

On 10 April 2014 the Benchmarking Advisory Committee (BMAC) discussed recommended changes to the CAUDIT Benchmarking System. EDUCAUSE Web accessibility issues

Some members may have experienced difficulties accessing the EDUCAUSE website and associated links recently. EDUCAUSE has advised CAUDIT that they had been blocking all IPs in the 203.x.x.x range. This was due to attacks from numerous IPs in this Asian-Pacific block of IPs. EDUCAUSE installed a new firewall and migrated existing addresses in the IP block list to this new firewall. On 19th April 2014 the 203.x.x.x block was removed from the firewall.
